

## **FAIR PROCESSING NOTICE: ONE GLOBAL CHANGEMAKER AWARDS 2023**

### **Identity and contact details of the controller and the data protection officer**

The “controllers” of your personal information are The ONE Campaign and its network of affiliates (“ONE”). Those affiliates include: ONE Action, ONE Global Canada, ONE Campaign Nigeria LTD/GTE, ONE Campaign Africa NPC, ONE Campaign Senegal, ONE Campaign gGmbH, and ONE Against Poverty UK.

This means that ONE decides the purpose and means by which your data is used in the awards process.

### **Purpose of the processing and the legal basis for the processing**

Your information is being used by ONE to decide the winners of the ONE Global Changemaker Awards 2023 (“Awards”).

If you consent to your nomination (as nominator or nominee) being considered in the Awards, ONE may contact you again to invite you to join our supporter email list; to invite you to attend the awards ceremony; or in relation to entering future Global Changemaker Awards.

### **Description of the categories of personal data**

The categories of information being processed include (for Awards nominees) your name, email address and background information submitted by the nominator to support your entry in the Awards; and (for Awards nominators) your name and email address.

We do not anticipate that we will process any ‘special categories’ personal data, which would include information related to your

- racial or ethnic origin
- political opinions
- religious or philosophical beliefs
- trade union membership
- genetic data [i.e. DNA data]
- biometric data [i.e. finger prints]
- data concerning health
- sex life or sexual orientation

### **Details of transfers to third country and safeguards**

Your personal data will be transferred outside the UK to the United States and other locations where ONE is based. In relation to such transfers, we shall: (i) ensure that you have enforceable rights and effective legal remedies; (ii) comply with our obligations under data protection legislation by providing an adequate level of protection to any personal data that is transferred; and (ii) comply with reasonable instructions notified to us in advance by you with respect to the processing of your personal data.

## **Compliance with Data Protection Legislation**

We shall ensure that:

- (i) we have in place appropriate technical and organisational measures, to protect against unauthorised or unlawful processing of your personal data and against accidental loss or destruction of, or damage to, that personal data, appropriate to the harm that might result from the unauthorised or unlawful processing or accidental loss, destruction or damage and the nature of the data to be protected, having regard to the state of technological development and the cost of implementing any measures;
- (ii) all personnel who have access to and/or process your personal data are obliged to keep the personal data confidential;
- (iii) we notify you on becoming aware of a Personal Data breach;
- (iv) we respect your rights under applicable data protection legislation.

## **Disclosures**

We may share your personal information with members of the judging panel for the purposes of administering the Awards, and make public your name if you are a winner in the Awards.

We may also disclose your personal information as necessary to comply with any applicable law, regulation, legal process or enforceable governmental request.

## **Retention period or criteria used to determine the retention period**

Your data will be kept for so long as is reasonably necessary to administer the competition, and in no event later than 31 January 2024.

## **Data subject's rights**

Data protection legislation provides you with the following rights when it comes to your personal data:

- To withdraw any consent that you have provided to us to process your personal data.
- To access or rectify your personal data.
- To have your personal data erased if it is no longer necessary for the purposes for which it was processed, you have withdrawn your consent to, or object to, its processing and there is no other legitimate grounds for processing it or you consider it has been unlawfully processed.
- To have the processing of your personal data restricted if you contest its accuracy, its processing is unlawful, we no longer need it but you need it for a legal claim, or you have objected to its processing and await verification of our legitimate grounds for processing it.
- To have your personal data transferred to another company under certain circumstances.

## **The right to lodge a complaint with a supervisory authority**
